

# **ASEAN Circular Economy Business Alliance (ACEBA)**

#### **WHO WE ARE**

The <u>ASEAN Circular Economy Business Alliance (ACEBA)</u> is an ASEAN-centric business-led alliance that spearheads a principles-based model for circular economy (CE)<sup>1</sup> for adoption by businesses in Southeast Asia in support of the regional circular economy transition. ACEBA is inspired by the richness of CE business experiences already present within the region, and seeks to foster wider CE adoption through knowledge and best practice sharing, business to business learning, and networking.

ACEBA is an initiative of **ARAIBA Sdn Bhd**, a purpose-driven, not-for-profit business organization that fosters inclusive and responsible business in ASEAN. It was launched on 22<sup>nd</sup> July 2024 in Jakarta, Indonesia, with the endorsement of the ASEAN Secretariat, the ASEAN Coordinating Committee on Micro, Small and Medium Enterprises (ACCMSME), the European Union Delegation to ASEAN, and the ASEAN Business Advisory Council (ASEAN-BAC).

The <u>EU SWITCH-Asia Policy Support Component</u> (PSC) supported ACEBA's preparatory fact finding and consultations in Cambodia, Indonesia, Laos, Malaysia, the Philippines, Thailand, and Vietnam. This has already produced over <u>80 CE business cases</u> that demonstrate diversity in approaches, benefit to climate and environment, and practical business opportunity. This also led to the development and validation of a principles-based <u>framework</u> for business action on the circular economy, which is the foundation for ACEBA's advocacy, knowledge sharing, and capacity-building efforts.

# ACEBA is working towards:

- **Building business leadership and guiding action** for CE adoption by Southeast Asian businesses.
- **Positioning CE as a regional agenda** for responsible and inclusive business promotion and action.
- Supporting evidence-based public and policy dialogue and knowledge sharing on CE, and related issues and concerns.

#### **REGIONAL HUB**


